Additional Information:

Registration fees are for dance tuition only. From time to time, additional amounts will be required for extra examination preparation classes and examination registration fees to be remitted to the ISTD or RAD. Uniforms and footwear are not included in the tuition fee.

It is part of the philosophy of Swan Studio Dance that qualified students be permitted to participate in appropriate examinations as conducted from time to time by either the Royal Academy of Dance (Ballet) or the Imperial Society of Teachers of Dance (Modern, Jazz). Examination tour dates are set by the RAD or ISTD, and in that regard, remain outside the control of the Studio. Student participation in any examination as a representative of Swan Studio Dance shall be determined exclusively by Swan Studio Dance.

Liability for Loss or Injury:
